## YMCA MEMBERSHIP AGREEMENT (Please read and sign)

- I understand that this membership will remain in effect for as long as I retain the membership card issued to me.
- It is to my complete understanding that if I wish to terminate or change my membership in any way, I must give the YMCA a 15-day written notice from my draft date. I understand that I must return all of my membership cards upon termination and that I will receive temporary cards for the balance of the time I have paid or will be paying.
- The YMCA Board of Directors may, at their discretion, adjust the monthly rate applicable to my category of membership. Rates are subject to change at any time without prior notice.
- Membership cards remain the property of the YMCA and must be surrendered upon demand of the institution.
- The YMCA has authorization to charge the difference between member and non-member rates if I terminate my membership or if my membership expires while I am in the middle of a class session.
- 6. If this is a corporate membership and the corporation becomes inactive or no longer wishes to participate, membership fees will be adjusted to current membership fees at the time of notification.
- 7. Applicable to draft only: I am responsible for any uncollected funds. My membership will be terminated if I have two (2) uncollected drafts on record at the same time, I close my account without notification, stp payment on my draft or revoke authorization. Any penalties imposed by my bank of the YMCA for uncollected drafts are my responsibility. The YMCA charges a \$25 service fee for all returned drafts due to non-sufficient funds, account closing or stop payment.
- 8. Applicable to draft only: Should any membership draft not be honored by my bank for any reason, I realize that I am still responsible for that payment plus a service charge applied by the YMCA. This is in addition to any service fee my bank may make.
